**RELEASE OF LIABILITY, HOLD HARMLESS AGREEMENT,
COVENANT NOT TO SUE, AND INDEMNITY AGREEMENT
Dodge County Humane Society Dog Walk / August 15, 2009**

Introduction

Independently of the Registration Form that I am signing separately, I understand that the Dodge County Humane Society ("the Humane Society") as further consideration for my participation in the Dog Walk offered on August 15, 2009, requests that I agree to release the Humane Society of liability for certain claims, hold the Humane Society harmless on certain claims, covenant not to sue the Humane Society on certain claims, and agree to indemnify the Humane Society against certain claims, as described below; and

I understand and acknowledge that:

- The Humane Society is offering me the opportunity to participate in the dog walk with my dog walk;
- Physical activity and interactions with other pets and people carry certain dangers, hazards and risks associated with those activities;
- The risks described above include the potential for serious bodily injury and/or death to me and/or to my family members and/or my dog(s) that may arise due to the inherent risks of the activities encompassed in the dog walk; and the risks may arise due to causes that may include, among others, aggressive and/or unpredictable behavior by dogs, including, but not limited to, biting, that may result in bodily injury to me, my family members and/or my dog(s); sudden movements and/or startling of dogs or people as a result of crowd noise or other persons' or animals' actions, which may result in unpredictable behavior by dogs or people; and/or improper or careless handling of the dogs and/or negligent oversight of them and of other people by any persons;
- My participation in the Dog Walk is voluntary and a product of my own free will;
- I have the opportunity, if I so choose, to decline to participate in the Dog Walk if I wish to avoid any of the risks associated with Dog Walk; and

In consideration of all of the foregoing, I hereby elect to participate in the Dog Walk, and in order to do so, I am willing to assume all of the associated risks; and therefore, I agree to the following:

Release of Liability

I hereby release the Humane Society and its successors, assigns, heirs, directors, officers, employees, insurers, volunteers, representatives and agents from liability for and on any and all claims and demands that I could, now and/or at any time in the future, make, assert, lodge, and/or bring against the Humane Society for damages, whether based in negligence, alleged to be grounded in statutes or based on any other legal theory, that:

- Arise out of or relate in any way to my participation in the Dog Walk; and/or
- That arise out of the conduct of any person who is acting for or on behalf of the Humane Society in connection with the Dog Walk.

This release specifically includes, but is not limited to, claims for damages related to and/or arising out of any of the following: Physical and/or emotional injuries to me and/or any members of my family; physical and/or emotional injuries to any other person; damage to any real property/real estate; damage to my financial interests and/or those of any members of my family; and/or damage to any tangible property.

Hold Harmless Agreement

In addition to the foregoing, I hereby agree to hold the Humane Society and its successors, assigns, heirs, directors, officers, employees, insurers, volunteers, representatives and agents harmless from any and all liability on any claims, or portions thereof, described in the Release of Liability in this document.

Covenant Not to Sue

In addition to the foregoing, I hereby agree and covenant not to sue the Humane Society and not to sue any of its successors, assigns, heirs, directors, officers, employees, insurers, volunteers, representatives and agents on any claims, or portions thereof, described in the Release of Liability in this document.

Indemnification Agreement

In addition to the foregoing, I hereby agree to indemnify the Humane Society and its successors, assigns, heirs, directors, officers, employees, insurers, volunteers, representatives and agents for any and all damages it/they may sustain and/or be found to owe and any and all attorneys' fees, litigation expenses and court costs that it/they may incur (1) as a result of or related to any claims made against it by other people or business organizations that arise wholly out of my conduct, whether that conduct is asserted to be negligent, intentional, or otherwise a basis for liability; (2) for the portion of any

claims brought against the Humane Society and/or its successors, assigns, heirs, directors, officers, employees, insurers, volunteers, representatives and agents that arise out of my conduct, whether that conduct is asserted to be negligent, intentional, or otherwise a basis for liability; (3) for any attorneys' fees, litigation expenses and court costs that it/they may incur as a result of or related to the defense of any claim, action or lawsuit relating to the claims released in the Release of Liability in this document; and (4) as a result of any loss-of-consortium claims brought by my spouse and/or any member of my family as a result of injuries that I may sustain due, in whole or part, to my participation in the Dog Walk.

General Terms

In addition to the foregoing agreements, I agree to the following general terms for all of the above agreements:

Severability. I agree that if a court of competent jurisdiction should decide that any of the agreements in this document and/or that any portions of them are illegal, unenforceable, or void as a matter of public policy or otherwise, such a determination shall not affect the validity or enforceability of the remaining provisions and agreements in this document.

Damage Limitation in the Event of Invalidity. I also agree that if a court of competent jurisdiction determines that the Release of Liability in this document or any part of it is illegal, unenforceable, or void as a matter of public policy or otherwise, then I hereby consent to a limitation of all liability for any injury, death, damage, or loss to me and/or any member of my family to no more than \$100.00 in total damages, regardless of the number of persons or entities named or alleged to be answerable for the alleged damages, which damages must be specifically alleged and proved in a court of competent jurisdiction.

Representations of Participant: In consideration for the opportunity to participate in the Dog Walk, I represent to the Humane Society that I do not have any physical, emotional or medical conditions that may endanger me or others participating in the Dog Walk other than those listed below:

Scope. The agreements in this document shall be effective and fully binding upon my heirs, next of kin, executors, administrators, and assigns in the event of my death.

Additional Provisions Applicable if Participant is a Minor Child. If the participant is a minor child, the agreements contained in this document shall be amended hereby so that all agreements, undertakings and obligations are joined by the parents and legal guardians of the minor child signing below on behalf of the minor child. By signing below, the Parent/Legal Guardian represents and warrants that s/he is the parent or legal guardian of the minor child and has authority to consent to the minor child's participation in the Dog Walk and that s/he does expressly consent to the minor child's participation in the Dog Walk. In addition to the prior indemnification obligations set forth in this document, the parents and legal guardians of any minor child that participates hereby expressly agree to indemnify and hold harmless the Humane Society and its successors, assigns, heirs, directors, officers, employees, insurers, volunteers, representatives and agents from any and all claims, losses, costs or expenses of any kind, including attorneys fees, that it/they may incur as a result of any lawsuit, claim or demand made by said minor child and/or by any and all parents and/or guardians of the minor child against the Humane Society and/or its successors, assigns, heirs, directors, officers, employees, insurers, volunteers, representatives and agents relating to the minor child's participation in the Dog Walk. The signing parents' and legal guardians' obligations to indemnify the Humane Society and its successors, assigns, heirs, directors, officers, employees, insurers, volunteers, representatives and agents as set forth in this document and in this paragraph shall include, but not be limited to, any such lawsuit, claim or demand that may be asserted after said minor child reaches the age of majority.

THESE AGREEMENTS WAIVE LEGAL RIGHTS YOU MAY HAVE, INCLUDING THE RIGHT TO SUE FOR DAMAGES. READ CAREFULLY BEFORE SIGNING.

I HAVE BEEN GIVEN AMPLE TIME TO READ THE TERMS OF THE RELEASE OF LIABILITY, HOLD HARMLESS AGREEMENT, COVENANT NOT TO SUE, INDEMNIFICATION AGREEMENT, AND GENERAL TERMS SET FORTH ABOVE AND I AGREE TO BE BOUND BY THEM IN CONSIDERATION FOR MY PARTICIPATION IN THE DOG WALK, AND I ELECT TO PARTICIPATE IN THE DOG WALK NOTWITHSTANDING ANY RISKS TO ME.
